WARNING: THIS IS A LEGAL DOCUMENT WHICH AFFECTS YOUR RIGHTS.

I agree to participate in Triathlon, Duathlon and Aquathlon competition and training ("events") on the following basis, as a condition of this application to join Balmoral Triathlon Club, Inc.:

1. By participating I accept all risks necessarily flowing from my participation which would result in loss of life or any injury loss or damage. Accordingly, I release all people associated with the conduct of events from, and will indemnify them against, all liability (including liability for their negligence) for all injury, loss or damage arising out of or connected with my participation in events. For clarification, the people released include event organisers, promoters, sponsors and managers, the Balmoral Triathlon Club Inc., the Triathlon NSW Association Inc., Triathlon Australia Ltd, other state and territory associations, triathlon clubs and all their respective directors, officers, employees, agents, contractors and volunteers including event medical and paramedical personnel. This release and indemnity continues forever and binds my heirs, executors, personal representatives and assigns.
2. I acknowledge that events include the real risk of serious injury, or risk of death from various causes including but not limited to over-exertion, equipment failure, dehydration, accidents with or without other competitors, spectators and road and facility users, the course and weather conditions.
3. I understand that I should not participate in events unless I have prepared appropriately and am medically fit.
4. I understand that the information I have provided herein will be included in a Balmoral Triathlon Club Inc. database and may be disclosed on occasion to Triathlon Australia Ltd, Triathlon NSW Inc., the Australian Institute of Sports Commission, State Institutes and Academies of Sport, the Australian Sports Drug Agency, our insurers and any other organisation as disclosed from time to time by Balmoral Triathlon Club Inc. I also understand that information of biographical nature including my name, home state, results, sporting career highlights and interests may be released to the media in response to general requests.
5. I understand that compulsory insurance cover effected for participants in events and training does not cover me for all injury, loss or damage sustained by me.
6. I understand I may contact Triathlon NSW if I wish to obtain a Summary of Insurance Cover.
7. The sanctioning process undertaken by Balmoral Triathlon Club Inc. and Triathlon NSW Inc. and safety precautions undertaken by event organisers (such as course supervision, race safety briefings, visual bicycle and visual helmet safety checks) are a service to me and other competitors but are not a guarantee of safety.
8. I agree to abide by all the rules of Balmoral Triathlon Club Inc. and to the rules of Triathlon Australia which relate, in part, to safe and fair sporting practices.
