PRIVACY POLICY

Our commitment to your privacy

This Privacy Policy outlines our practices relating to the collection, use, disclosure and storage of your personal and sensitive information. Personal and sensitive information is generally information about an individual that makes the identity of an individual reasonably apparent. Unless you give us explicit consent otherwise, we will act in accordance with this Privacy Policy with regard to our collection and use of personal and sensitive information.

The information we collect

We will only collect personal and sensitive information that is reasonably necessary for us to provide you with, or directly related to, the activities that we offer as Balmoral Triathlon Club ("Club"), as described in our website balmoraltriclub.org.au ("Site").

The personal and sensitive information which the Club collects may include, without limitation, your name, age, gender, postal address, email, telephone number and relevant medical information.

We collect personal and sensitive information from you when you interact with the Club, which could include when you become a member of the Club, when you register to participate in activities conducted by the Club, or when you use any features on the Site once you have joined or registered. When you access our Site via a browser or application, our servers automatically record certain information. These server logs may include information such as your web request, your interaction with a service, Internet Protocol address, browser type, browser language, the date and time of your request and one or more cookies that may uniquely identify your browser or your account.

How we use your information

You agree that your personal information can be stored and used by the Club. We will only use your personal and sensitive information for the activities conducted by the Club. Such use may include the provision of your information to attendees at events, such as an event roster, results' pages or, if you have authorised us to do so, to sponsors who sponsor Club activities ("Sponsors").

You agree that your name and contact details can be used by the Club and, where you have authorised us to do so, by Sponsors, for the purposes of:

- Adding you to a mailing list to keep you informed about the Club and its activities.
- Communicating with you for the promotion and marketing of forthcoming, similar Club activities.
- Communicating with you for assistance in Club activities.
- Where you have so authorised, promotion and marketing of Sponsors' goods, services and activities.

You can unsubscribe from receiving these communications at any time.

Please remember that any information that you post in our public forums and any social media interfaces is public information and will not be treated as confidential. Such information can be collected and used by others. Please be careful and responsible when you are online.

Sharing your information

We will take all necessary steps to ensure that personal information or marketing information pertaining or relating to you which comes into the possession or control of the Club will not be used or reproduced in whole or in part in any form except for the purposes outlined in this Privacy Policy.

We will only disclose your personal and sensitive information in the following circumstances:

- When we have your consent.
- To third parties where necessary for us to provide our services to you, or where you
 have expressly asked us to do so for the purposes of them or us providing further
 services. These third parties may include, without limitation, banks and payment
 processors.
- To comply with any law enforcement agency, judicial proceeding, court order, or legal process in any jurisdiction that is investigating any breach or suspected breach of any law in any jurisdiction regarding your identity or other personal and sensitive information provided by you to us.
- Where disclosure is reasonably necessary to enforce our agreements with you or any rights we have, including investigation of potential violations, or to detect, prevent, or investigate a matter relating to security, fraud or other technical issues.
- Where disclosure is reasonably necessary to protect the Club's rights or intellectual property or to protect the safety of the Club's officers, members or the public as required or permitted by law.
- Where we are otherwise permitted by law to disclose your personal and sensitive information.
